Performing duties according to law formality of Royal Thai Police with transparency Do not show behavior that has implications for illegal exploitation. Be responsible for your human rights duties. Be ready to receive audits and accept responsibility. Have a good conscience, consider society and item ๒(๔), think about public benefits more than personal benefits, have a public mind, cooperate, join together, and sacrifice in making benefits for the public. and creating benefits and happiness for society, together with plans to reform the country in terms of preventing and suppressing corruption and misconduct (Revised Edition) Set out important reform activities. herefore, in order to prevent conflicts between personal and public interests, accepting bribes, gifts, gifts, or any other benefits that affect the performance of duties, guidelines for anti-receiving of duties have been established. and not accepting gifts, favors, or other benefits from performing duties The details are as follows:

Article ๑ This announcement

“Commander” means a person who has the authority to command, supervise,

monitor, and inspect. Police officers under

“Bribe” means property or any other benefit given to a person to induce that person to act. Doing or not doing anything in the position Whether it is right or wrong according to duty

“Performing duties” means the actions or performance of duties of government officials in appointed position or has been assigned to perform any duties or to act instead In any duty, both general and specific as a police officer, as determined by law. Powers and duties or acts in accordance with the powers and duties specified by law to be the powers and duties of the police.

“Gifts, presents, or any other benefits that affect the performance of duties” means money. Property, services, or other benefits that are of value and are provided, including tips. Government officials receive in addition to salary, income, and government benefits in normal cases and affect decisions, approvals, permissions, or anything else in performing their duties in a manner that benefits the provider in a dishonest way. Gifts from the past or at the time of receipt or in the future “

Article 10: Police officers at all levels shall conduct themselves as follows:

10. Do not ask for advice, do not give or accept bribes, gifts, gifts or any other benefits from Perform duties

10. Do not consent or connive with family members giving or receiving bribes, gifts, gifts, or Any other benefits to those involved in performing duties

10. The performance of duties must be based on enforcing the law with fairness, benefit and The image of the police is important. Must not do anything that is a conflict between personal interests and public interests, such as accepting gifts. or any other benefits that affect the performance of duties, use of government resources Using stolen property for personal gain, disclosing inside information, blocking official time to do extra work, etc

10. Reduce the giving or receiving of property or any other benefits in accordance

with the principles and ethics. The amount specified by the NACC Office, using the method of expression by signing greeting cards, greeting books, cards expressing condolences. or using social media instead of giving

๕. Do not accept, do not tolerate, do not ignore the behavior of accepting bribes, gifts, presents or any other benefits. from performing duties If any violations are found, the Superintendent/Station Head will be informed immediately.

Article ๓ gives the commander the authority to supervise, monitor, and inspect police officers under his supervision. Behave according to this announcement. In the event that an action that violates this announcement is found Report to the Superintendent/Station Head as soon as possible.

Article ๔. Anyone found to have acted in violation of this announcement. Complaints/clues can be reported directly through the Superintendent at Lahan Sai Provincial Police Station. or via telephone number ๐๙๐-๒๗๒๕๒๕๒, which information Complaint/Whistle Informer will be concealed and kept strictly secret.

Article ๕: In the case of receiving a complaint/clues Personnel under the jurisdiction to commit such offenses at the police station will conduct an investigation. And if an offense is found, the offender will be punished strictly in accordance with relevant laws, rules and regulations. and send matters according to the next command hierarchy
